

## 2026 Ontario Tech University Child & Youth Programming Assumption of Risk and Release of Liability

Please read this document carefully before submitting the online registration form. Your submission (i.e., registration and payment) for a virtual and/or in-person camp or Youth Safety Course (the Program) confirms that you have read, understood, and accepted the following:

## **ASSUMPTION OF RISK**

Participation in the Program is conditional on the acceptance of certain inherent risks, dangers, and hazards of the Program. The Parent/Guardian acknowledges and agrees that participation in the Program is voluntary, the Camper/Participant is of appropriate capacity for the limited purpose of Program participation, and that participation is at the Camper's/Participant's own risk. Risks may include, but are not limited to:

- **WEATHER**: any injury or illness resulting from exposure to heat, sunlight, humidity, wind, inclement weather, floods, and natural disasters
- **FACILITIES/EQUIPMENT**: any injury resulting from use, misuse or non-use of facilities, equipment, protective personal equipment, whether or not in accordance with instructions
- ACTIVITIES: any injury or illness resulting from the activities that are known, or ought to have been reasonably known, to occur during the Program (i.e., physical exertion, sports, dance, cooking, building, computer use)
- OTHER PARTICIPANTS: any injury, illness, or loss resulting from the acts or omissions of other participants in the Program, including but not limited to physical contact that may occur during activities or interactions, whether accidental or intentional, whether or not in accordance with instructions
- VISITORS/TRESPASSERS: any injury, illness or loss resulting from the acts or omissions of third-party visitors or trespassers attending Ontario Tech University premises
- TECHNOLOGY: any property damage, loss of data, loss of use or functionality of hardware and software, services interruptions, and other costs, losses, delays, and inconveniences, that may be sustained by the Participant or by any property belonging to the Participant resulting from the installation, download and/or use of a third-party software and/or digital platform to participate in/attend the Program

During a virtual camp session, Parents/Guardians are responsible for supervising their Camper/Participant. The Parent/Guardian is solely responsible for providing/securing any health, medical or dental insurance for the Camper/Participant. Any disability, allergy or other medical condition that may affect the Camper's/Participant's involvement in the Program must be indicated by the Parent/Guardian at the time of registration.

By completing Program registration, the Parent/Guardian voluntarily accepts and agrees, on behalf of the Camper/Participant, to assume all costs, risks, dangers and hazards, including the possibility of personal injury, death, property damage or loss, and other delays/inconveniences resulting from the acts or omissions of Ontario Tech University, its directors, officers, employees, students, volunteers, contractors, agents, and partners in the administration of the Program as outlined in the below **Release of Liability**.

## RELEASE OF LIABILITY

In consideration of the acceptance of my application (i.e., registration) for my child (the Camper/Participant) to participate in Ontario Tech University Child and Youth Programming, I hereby agree to fully and forever release and discharge Ontario Tech University and any program partners, including their respective directors, officers, employees, students, volunteers, contractors, and agents (collectively, the "releasees") from any and all liabilities, claims, suits, costs and losses on account of personal injury (including death), illness and property loss or damage, directly or indirectly arising out of or relating to the Camper's/Participant's attendance and involvement in the Program however caused, whether in contract, tort, negligence, statutory liability, or brought under other legal or equitable theory.
