

Ontario Tech University Virtual Camps 2022 Code of Behaviour and Release of Liability

Please read this document carefully before submitting the online registration form. Your submission confirms that you have read, understood, and accepted this release, waiver and discharge.

We want you to be secure in knowing that your child(ren) will be enjoying their virtual camp experience in a positive, safe, enjoyable environment. The following Code of Behaviour is designed to provide you and them with that security.

Code of Behaviour

1. Be safe
2. Be kind to yourself and others
3. Respect yourself and others
4. Listen to others and follow directions
5. Have fun!

Safety and behaviour – Ontario Tech University recognizes the right of campers to have a safe, productive learning experience and to foster a tolerant environment. Therefore, campers are expected to adhere to the code of behaviour as detailed above and explained during the first day of each camp session.

Campers and parents should be aware that the following are non-negotiable, “removal from camp” situations. If a student is removed for any one of the reasons listed below, no refund will be given.

- Deliberate disruption of the planned program and scheduled activities.
- Rudeness or unwillingness to follow reasonable instructions and directions.
- Disrespect towards another’s rights and privileges of the other campers, counsellors or instructors.
- Invasion of privacy, such as taking photos, videos, and/or transcripts of online sessions.
- Visible use of or discussion about the use of alcohol, cigarettes, cannabis, narcotics or any illegal substance.
- Misuse of platform technologies such as chat functions, microphone, presentation mode.
- Other acts that can or do result in the violation of a safe and positive environment (example: bullying, offensive language, etc.)

Release, Waiver and Discharge
