

# Return to Campus and Vaccinations

- Navigation of community pressure around vaccine mandates, masking, and other public health measures; as well as changing provincial/territorial/national expectations.
- Launch and conclusion of related lawsuits.
- Preparing for an in-person return with a community of varied comfort-levels and interest.



# Truth, Reconciliation, and Residential Schools

- Confirmation of the unmarked graves at Residential Schools and supporting nearby communities.
- Cases of Indigenous identity fraud & discussion of prevention.
- Increased pressure for renaming buildings and institutions, removing statues, and eliminating other references to certain figures.
- The renaming of Toronto Metropolitan University.



# Institutional Stability & The Laurentian Story

- Laurentian embarked on CCAA court proceedings in February 2021. This was quickly followed by layoffs, program cancellations, and severance of relationship with affiliate institutions.
- Institutional closures and mergers in the US, private college sector in Canada.
- Creation of uncertainty about the stability, transparency, and permanence of the sector more broadly: "Could this happen elsewhere? To us?"



# The Changing Role of Colleges

- Transformation of several colleges into polytechnic institutions
- Expanded 3-year and applied 4-year degree offerings
- Very well positioned to meet the increased demand for career-focused education (identified as leading reason for applying to PSE in Academica's UCAS 2021 study).



# Rapid Reskilling and Micro-Programming

- Short term reskilling and upskilling programs exploded in popularity during the pandemic.
- Micro-credentials have been the short-term program of choice in provinces like Manitoba and Ontario.
- More recently, the launch of shared definitions, resources, and guidelines for the development of micro-credentials.



# Wellness in an Extended Crisis


- Launch of the National Standard of Canada for Mental-Health and Well-Being for Post-Secondary Students by the MHCC in October 2020.
- Launch of dedicated resources by provincial organizations like BCcampus.
- Significant funding from ON, PEI, SK, BC to support student mental health.
- Some questions around the wellbeing of staff, faculty, and others who either were unable to work or unable to take a meaningful break for extended periods of time during the pandemic.

#### International on Pause

- Significant decrease in international enrolment at several postsecondary institutions in Canada at the start of the pandemic.
- ON Auditor General identified the province's postsecondary sector's reliance on international students as a "serious financial risk" to the system.
- Some institutions shifted attention to international students who were already landed, including recertification programs for newcomers and dedicated training for graduating students.

### Environmental Action

- Major student and community pressure to divest.
- Infrastructure updates and renovations to make campus environmentally friendly.
- Achievement of net-zero campuses at Université Laval and École de technologie supérieure, well ahead of both institutions' schedules.
- New programs and growing enrolment in environmentrelated programs, accompanied by a decline in oil-andgas focused programming.



# Supporting Black Scholars and Learners

- Signing of the Scarborough Charter.
- Launch of special scholar opportunities and admissions pathways, such as McMaster University's Equitable Admissions for Black Applicants pilot project.
- Launch of new incubators, research hubs, programs, and partnerships to support Black students.



# Online Learning and the Future

- Reflecting on two years of online 'emergency' education and comparing 'band-aid' to 'best' online practices.
- Determining what to preserve, what to change, and what to remove as in-person education becomes possible again.
- Student expectations and institutional performance have been redefined by the last two years, so 'being competitive' in today's market has new considerations.
