Proposal Brief

Summary of the proposed change

LGLS 1000U – Foundations of Legal Studies will replace the SSCI 1010U – Intro to Canadian Legal System course and be included in the common first-year core for all BA programs in FSSH.

Description of the ways in which the proposed change will enhance the academic opportunities

The introduction of LGLS 1000U is a response to the recommendations from the external review of the Legal Studies program (January 2016). It is also reflective of the Faculty's decision to create a common 1st year core, with courses introducing each of the disciplines taught in our Faculty. Offering Foundations of Legal Studies would bring us more in line with other existing courses such as Introduction to Communications, Introduction to Psychology, Introduction to Sociology, etc. LGLS 1000U will provide students not only with knowledge of the basics of the Canadian legal system (structure of government, court system, and the principles, sources, and types of law) but also with critical perspectives on law and its role in society as well as a general understanding of the discipline of legal studies, which will enhance student learning.

Process of consultation with other units if the change(s) involves students, staff and faculty from other programs of courses

The new course was developed by the Legal Studies program and was discussed at the Faculty Undergraduate Curriculum Committee and at the Faculty Council. The Faculty's budgeting office has also been consulted.

Transition Plan

The changes will primarily impact incoming students. Any current students who did not take SSCI 1010U at the usual time, would now take the new LGLS 1000U course instead.

Analysis of the financial and enrolment implications

The course will use approximately the same amount of TA hours as SSCI 1010U. Thus, there are no financial implications in relation to TA support.

Given LGLS 1000U will replace SSCI 1010U, the enrolment in the course is expected to be the same as for SSCI 1010U. LGLS 1000U will be a required 1^{st} year course for all of the Faculty's programs.

Proposed Implementation Date

This change will be implemented for the 2017-18 academic year.
