SUBJECT: 2021 Election Results

MANDATE:

- Section 1(b) of the GNC Terms of Reference lists one of the responsibilities of the committee as overseeing the process of recruitment, selection, and election of new members of Academic Council and its committees and recommending appointments for approval by Academic Council in accordance with the university's Act and By-laws.
- We are reporting on the election process and results of the 2021 Academic Council Election.
- The GNC is seeking Academic Council's approval of the appointments of the successful teaching staff and student candidates.

BACKGROUND/CONTEXT:

- The 2021 Academic Council Election took place from February 8 – February 22 in accordance with the Election Timeline that was approved by the GNC in October 2020.
- There were 13 vacant positions on Academic Council (AC) and 9 vacant positions on its standing committees.
- Of the nominations received by the nomination deadline, the number of candidates for each role did not exceed the number of vacancies available.
- The candidates' eligibility to participate in the election was confirmed.
- In accordance with section 4.8 of the Academic Council Procedures for the Election of Teaching, Non-Academic Staff and Student Representatives ("Election Procedures"), "When the Nomination Period has closed, if the number of candidates nominated is equal or less than the Academic Council positions available in a particular constituency, the candidates shall be acclaimed."

ADDITIONAL NOMINATION:

- Following the 2020 Academic Council Election, there remained a number of vacancies on AC and its committees.
- The GNC directed the Office of the University Secretary and General Counsel to post the vacant positions on the website and to continue to accept nominations until the end of the academic year.
- Following the close of the 2021 AC Election Nomination period, a nomination from Helene Marie Goulding (current member of the Academic Appeals Committee) for one of the vacant Teaching Staff positions on the Academic Appeals Committee.
- The candidate's eligibility to serve in the role was confirmed.
- The GNC has recommended the appointment of the candidate to the Academic Appeals Committee for the term of July 1, 2021 – June 30, 2024.
