## GNC MANDATE:

- Section 1 of the Governance \& Nominations Committee (GNC) Terms of Reference states that the Committee is "responsible for providing advice to Academic Council on its governance structure and processes".
- The restructure of the Faculty of Energy Systems \& Nuclear Science (FESNS) in June 2022 has created ambiguity as to the status of individuals serving on Academic Council and its Committees who were elected or appointed from the Faculty.
- The membership requirements of By-Law 2 and the Terms of Reference of Academic Council Committees vary in their rigidity with respect to Faculty membership. The requirements of each are set out in the BACKGROUND portion of this memorandum.
- In accordance with their Terms of Reference, the membership of the following Committees is not impacted by the restructure of FESNS:
o Steering Committee;
o Academic Appeals Committee; and
o Honorary Degrees Committee.
- As a result of their current composition, the membership of the following Committees is not impacted by the restructure of FESNS:
o Governance \& Nominations Committee;
o Undergraduate Studies Committee; and
o Graduate Studies Committee.
- The membership of both Academic Council and Research Committee is impacted by the restructure of FESNS. Each body has one individual whose membership is derived from affiliation with the restructured Faculty.

As a result, it is recommended that their appointments be terminated.

- The ending of the appointments below was endorsed by GNC at its meeting on September 20, 2022.

- The termination of Daniel Hoornweg's appointment to Academic Council effective September 27, 2022; and
- The termination of Kirk Atkinson's appointment to Research Committee effective September 27, 2022.


## BACKGROUND:

## ARTICLE 2 - COMPOSITION

### 2.1 Ex-officio Members

In accordance with section 10 of the Act, the Academic Council will be composed of the following ex-officio members:
a. the Chancellor;
b. the President;
c. the Provost and Vice-President, Academic;
d. the Dean of each Faculty and School of the University;
e. the Registrar;
f. the University Librarian;
g. the senior administrator responsible for Student Life;
h. the academic administrator responsible for Quality Enhancement;
i. the academic administrator responsible for Research;
j. a Governor; and
k. the Council of Ontario Universities Academic Colleague (non-voting).
2.2 For the purpose of determining quorum, the following ex-officio members will be counted as Teaching Staff:
a. the Provost and Vice-President, Academic;
b. the Dean of each Faculty and School of the University;
c. the academic administrator responsible for Quality Enhancement; and
d. the academic administrator responsible for Research.

### 2.3 Elected Members

a. Faculty, elected from among full-time continuing Associate Deans, tenured and tenure-track faculty and teaching faculty, in the following numbers:
(i) Faculty of Business and Information Technology - three (3)
(ii) Faculty of Education - one (1)
(iii) Faculty of Energy Systems and Nuclear Science - one (1)
(iv) Faculty of Engineering and Applied Science - three (3)
(v) Faculty of Health Sciences - three (3)
(vi) Faculty of Science - three (3)
(vii) Faculty of Social Science and Humanities - three (3)
(viii) Faculty At-Large - eight (8)
b. Students, elected from among their respective constituencies, in the following numbers:
(i) undergraduate - four (4)
(ii) graduate - two (2)
c. one (1) Administrative Staff member, elected from among the Administrative Staff

- The membership requirements of each of the Committees of Academic Council as provided in their respective Terms of Reference is set as follows:

- Chair of the Academic Council committee responsible for research
- Secretary of Academic Council (non-voting)


## Elected Representatives from Academic Council

Between three (3) and six (6) elected representatives of Academic Council (Teaching Staff, Administrative Staff and Students) to ensure the Committee benefits from a balance of skills, expertise, and knowledge among its membership, while reflecting the demographic and cultural diversity of the communities served by the university.
