SUBJECT: Major Program Modification – Bachelor of Arts and Bachelor of Science in Psychology, including specializations, and Bachelor of Arts in Psychology - Advanced Entry

---

### COMMITTEE MANDATE:

In accordance with the Undergraduate Studies Committee (USC) Terms of Reference, USC has the responsibility “to examine proposals for new undergraduate degree programs and major changes to existing programs and to recommend their approval, as appropriate, to the Academic Council”.

### MOTION FOR CONSIDERATION:

That, pursuant to the recommendation of the Undergraduate Studies Committee, Academic Council hereby approves the Major Program Modifications to the Bachelor of Arts and Bachelor of Science in Psychology, including Specializations, and Bachelor of Arts in Psychology – Advanced Entry.

### BACKGROUND/CONTEXT & RATIONALE:

The Faculty is proposing the following changes:

1. Revise 1st year required courses for BA in Psychology (per changes to the degree requirements for the Bachelor of Arts in the Faculty of Social Science and Humanities);
2. Update modes of delivery for Psychology courses to include hybrid and fully online (synchronous and asynchronous) formats;
3. Develop psychology-specific Research Methods (PSYC 2900), Data Analysis (PSYC 2910U), and Advanced Data Analysis (PSYC 3910U) courses. These new courses will replace SSCI 2900U, SSCI 2910U, and SSCI 3910U as required courses for BA and BSc in Psychology, and BA in Psychology Advanced Entry.
4. Add existing courses PSYC 3620U – Motivation and Emotion and PSYC 3330U – Developmental Psychopathology to the list of courses that can count towards the Affective Science and Mental Health specialization; and

5. Add existing courses PSYC 3530U – Developmental Neuroscience and PSYC 3330U – Developmental Psychopathology to the list of courses that can count towards the Developmental Psychological Science specialization. PSYC 3330U can only count toward one specialization, not both.

**RESOURCES REQUIRED:**

No additional resources required.

**TRANSITION PLAN**

In Fall 2023, BA and BSc Psychology students in Years 1 and 2 and BA Psychology Advanced Entry students in Year 3 will be required to take PSYC 2900U, PSYC 2910U and PSYC 3910U in place of SSCI 2900U, SSCI 2910U and SSCI 3910U.

BA and BSc Psychology students in Year 3 and BA Psychology Advanced Entry students in Year 4 will have already taken SSCI 2900 and SSCI 2910. These students will be permitted to take PSYC 3910U without having to take PSYC 2900U and PSYC 2910U.

Any Psychology students who have successfully completed SSCI 2900U, SSCI 2910U and SSCI 3910U by Fall 2023 will be considered to have satisfied the degree requirements for their program.

The Undergraduate Program Directors, as well as the faculty members, of the Psychology and Forensic Psychology programs have discussed and agreed upon the changes. The program director of Criminology and Justice was also consulted. Academic Advisors also supported these changes based on their discussions with students.

- Pending the approval of Academic Council, the changes will be included in the 2023-2024 Academic Calendar.
