SUBJECT: Major Program Modification – Master of Arts in Education, Master of Education, and Graduate Diploma in Education and Digital Technologies

COMMITTEE MANDATE:

In accordance with the Graduate Studies Committee (GSC) Terms of Reference, GSC has the responsibility “to examine proposals for new graduate degree and diploma programs, major changes to existing programs and to recommend their approval, as appropriate, to the Academic Council”.

MOTION FOR CONSIDERATION:

That, pursuant to the recommendation of the Graduate Studies Committee, Academic Council hereby approves the Major Program Modifications to the Master of Arts in Education, Master of Education, and Graduate Diploma in Education and Digital Technologies.

BACKGROUND/CONTEXT & RATIONALE:

The Faculty is proposing the following changes:

1. Modify the required core courses for M.Ed and MA;
2. Remove the current Cluster system and all requirements associated with the Cluster system;
3. Replace the four Clusters with five new Themes;
4. Revise current course titles and descriptions;
5. Delete out-of-date courses;
6. Create new courses; and
7. Rename the Graduate Diploma as Education in the Digital Age

RESOURCES REQUIRED:

No additional resources required.

TRANSITION PLAN:

The proposed changes will begin Fall 2023. Current students will have greater flexibility in course selection to complete degree requirements, which are unchanged.

CONSULTATION AND APPROVAL:

- Faculty Council: 29 November 2022
- Curriculum Committee: 9 November 2022

All graduate faculty and administration staff have been involved in the process of modifying the program structure and creating/modifying the graduate courses we will offer in the program. The faculty have participated in multiple meetings and discussions and worked collectively on the proposed program changes over the past 14 months.

Graduate student feedback has been solicited on the new course offerings and the course descriptions.

NEXT STEPS:

- Pending the approval of Academic Council, the changes will be included in the 2023-2024 Academic Calendar.
