#### I would like to recommend:

That Academic Council approve the use of the accreditation guidelines for the Canadian Association of Schools of Nursing in the place of the Undergraduate Program Review guidelines for the review of the Bachelor of Science in Nursing program (including post-diploma) to be undertaken in 2008-09;

That Academic Council approve the following undergraduate program reviews in 2009-10:

Bachelor of Science in Chemistry (all specializations), Bachelor of Science in Physical Science, Bachelor of Science Physics (all specializations);

And that Academic Council approve the rolling schedule for Undergraduate Program Reviews, as set out in the attached.

## Rationale:

The Bachelor of Science in Nursing program (including post-diploma) is scheduled for review in 2009-10, and at the same time will be subject to accreditation appraisal by the Canadian Association of Schools of Nursing (CASN). The Health Sciences team has conducted a comprehensive comparison of the CASN accreditation standards and the undergraduate program review process and has confirmed that all of the requirements of our internal review process will be fulfilled by the more rigorous external accreditation process. Therefore, I am recommending that Academic Council approve the use of the CASN protocol in the place of the program review guidelines for the review of the BScN programs this year. Assuming successful achievement of accredited status, the results of th CASN review will be used to satisfy the UPR requirements. The documentation for the accreditation should be filed with the University's UPR materials in preparation for future audit.

In addition, UOIT's Undergraduate Program Review Policy requires that Faculties confirm with Academic Council the undergraduate program reviews to be undertaken in the next academic year and the rolling schedule for the next seven years.
