## 7. REGISTRAR'S REPORT

Victoria Choy put forward the following motion for action:

#### 1. GRADUATION NOTWITHSTANDING A DEFICIENCY

MOTION CARRIED *That the following student be approved for graduation notwithstanding a deficiency in his/her academic history:*

*Program: Bachelor of Commerce, Faculty of Business and Information Technology*

*Reason: The student has met all requirements for the Bachelor of Commerce and has achieved GPA above the average required for the program, but has not met the cumulative GPA standard required for graduation because the grades transferred from previous UOIT program are part of the overall GPA calculation.*

Ms. Choy observed that the form of this motion is specified in UOIT academic regulation 5.20. At Council's recommendation, the Registrar undertook to review the regulations and procedures that relate to a student's transfer from one program to another to ensure that the student's achievement in the new program is accurately reflected in the final grade calculation.
