# FACULTY OF SOCIAL SCIENCE AND HUMANITIES - PROPOSED MAJOR CHANGES TO COMMUNITY DEVELOPMENT PROGRAM

### Community Development and Policy Studies (program name-change from Community Development)

#### 1. Introduction

Currently, the Faculty of Social Sciences and Humanities houses both the Public Policy and Community Development programs. The Faculty proposes to close Public Policy, and integrate its strengths and complementary courses into Community Development, to better meet the needs of students. The faculty also proposes to change the program name from 'Community Development' to 'Community Development and Policy Studies' to better reflect the practical and theoretical interdependence of community development and social and public policy, as well as draw on current faculty strengths and course offerings.

Community Development and Policy Studies combines core course requirements to reflect integrated social and public policy and community development strengths, while offering a broader range of electives than when the programs were separated. The program continues to emphasize strategies for sustainable development, as well as implementation and design of social and public policy to the end of improving conditions on local, regional, national and global levels. The Community Development program's unique approach to theories of community and exploration of alternative, non-geographic communities is retained. Career and academic opportunities for students will be broadened as they gain knowledge particular to community development, social and public policy, and the links between them. Students will continue to develop skills to engage sensitively across diverse social groups as they assist in the building and revitalization of sustainable, just, and peaceful communities.

Several faculty members in communication, legal studies and criminal justice studies teach courses on policy relevant to those areas. Several faculty members focus their research on community development issues. Community Development and Policy Studies complements and builds particularly on faculty teaching strengths in policy, diversity and social structures in criminal justice and legal studies, directing those strengths towards grassroots, social and policy issues beyond criminal justice and law. Communication courses complement policy and social change aspects of community development.

Core courses in policy theory and in community development theory and methods are highly complementary. No new courses are necessary at this time.

xx. Program Information – Bachelor of Arts (Honours) in Community Development and Policy Studies.

Community Development and Policy Studies combines the fields of community development studies and policy studies in a dynamic and innovative program. This interdisciplinary program connects broader public policy concerns with community struggles to improve social, economic and environmental conditions. Broad conceptions of policy, community and development are explored in relation to diverse social issues related to poverty, inequality, technology, and the environment. The program emphasizes strategies for implementing and designing social and public policy to the end of improving conditions on local, regional, national and global levels. Students will develop skills to practice sensitively across diverse social groups as they assist in the building and revitalization of sustainable, just, and peaceful communities. Emphasis is placed on participation, decentralization, and democratization in the creation of policy as well as and the idea that development is a process in which communities are mobilized in the interest of social justice.

#### xx. Field Work Practicum

Fieldwork is an exciting opportunity for students within the varied programs in the faculty of Social Sciences and Humanities. The Fieldwork Practicum is an elective course for those students who have demonstrated capability to undertake placements with appropriate community and policy organizations. The Fieldwork Practicum provides students with the opportunity to confront relationships between theory and practice, acquire workplace knowledge and skills, and engage in personal development. Depending on timely availability of placements, students may undertake fieldwork with organizations that work in policy, urban and rural planning, international development, community development, social work, health and education, community advocacy, and more.

#### xx. Careers

There is a demonstrated need for graduates with the skills necessary to engage in the processes of community change and growth, and the implementation and development of policy to foster such change. This program develops skills and knowledge required for the pursuit of careers in community organizing and outreach, social policy, sustainable community development, international development, environmental policy, and community advocacy, in government, business, and non-profit sectors. Excellent grounding is provided for further studies in social work, law school, public administration, rural and urban planning, and related disciplines.
