1. CHAIR'S REMARKS

It was noted that a detailed response has been received from the Dean Vogel to address the concerns put forward in Item 3 of the Committee's report regarding the new specializations in Health Sciences.

6.2 CURRICULUM AND PROGRAM COMMITTEE

Dr. Muirhead presented the report of the Committee which contained one item for action and two items for information.

1. Bachelor of Health Science – New Specializations in Public Health and Human Health Sciences

MOTION CARRIED *That Academic Council approve the new specializations in Public Health and in Human Health in the Bachelor of Health Science Program as outlined in the Committee's report.*

In response to queries about the proposal including those contained in the Executive Committee's report, Dean Vogel noted that she had provided a detailed response that was added to Council's agenda. She observed that the new specializations do not constitute new programs, rather they are a repackaging of current curricular offerings. The students who are currently in the Comprehensive option will be accommodated through these new offerings which will better meet their needs, and any new enrolment

growth is growth that is expected to occur naturally in the Bachelor of Health Sciences program. The new courses will be phased in over a four year period amounting to 1.5 new course offerings per year. She also noted that existing and new faculty appointments are well suited to these new curricular offerings.

Dr. Muirhead also noted for information a series of changes that have been made to courses and requirements and the undergraduate program reviews to be undertaken in 2012-13.

6.2 ADMISSIONS AND SCHOLARSHIP COMMITTEE

Ms. Choy noted for information the Committee's selection of the winners of the Governor General's Academic Medals, and the Major Entrance Scholarships.

7. OTHER BUSINESS

Dr. Bradbury noted that Rameez Virji in the Bachelor of Science in Computer Science program was recently named one of Canada's Top 20 Under 20, by Youth in Motion, a program that identifies outstanding young Canadian leaders. On a motion, Council undertook to send congratulations to Rameez for this prestigious honour.
