## Changes to Forensic Psychology Program in the Academic Calendar

We have a few minor program changes to propose:

- We want to add PSYC 3060 Personality Psychology and remove PSYC 2830 Justice Theory and Policy and PSYC 3040 Restorative Justice from the Forensic Psychology electives in the Forensic Psychology major
- We want to move the Psychology of Law minor from Legal Studies to Forensic Psychology and rename it the Forensic Psychology minor
- We want to change the listing of courses in the Forensic Psychology minor

## 1. Changes to Electives Lists in the Major

We would like to add PSYC 3060 Personality and remove PSYC 2830 Justice Theory and Policy and PSYC 3040 Restorative Justice from the Forensic Psychology electives in the Forensic Psychology major.

• Rationale: We no longer have faculty to teach the removed courses from a psychology perspective so we are removing them as they no longer fit into our view of our major and minor. We do have the faculty to teach Personality Psychology and the course fits well with our view of the major
