**SUBJECT:** For Information - Recommended Language for Course Outline/Syllabus

---

**ACADEMIC COUNCIL MANDATE:**

- The Provost committed to providing updates to Academic Council relating to the COVID-19 return to campus planning task forces. The E-learning Task Force had questions relating to notification to students regarding certain issues. In response to those questions, the Task Force and the Provost asked the Secretariat for legal and policy advice. The Secretariat recommends the inclusion of certain revised/additional language in the recommended course outline/ syllabus template. This language is included in the attached to address the questions raised by the Task Force. The Provost has asked that we share this with Academic Council for the purposes of raising awareness of the recommended language and soliciting comments.

**BACKGROUND/CONTEXT & RATIONALE:**

- The E-Learning Task Force has been examining issues related to the remote/hybrid model of teaching that is necessitated due to public health measures currently in place.
- The E-Learning Task Force has recommended the development of standard language for faculty to include in course outline/syllabus. Recommended language has been developed in consultation with the university's legal counsel in each of the following areas:
- **Student Privacy:** Blended and online learning often includes the use of tools (such as remote proctoring) that capture video and audio of students. The use of such tools creates obligations around student privacy. Ontario privacy law requires notification of collection of personal information, including video and

audio recordings. Recommended notices of collection can be included in outline/syllabus to assist faculty in fulfilling these obligations.

- **Sensitive Content:** When sensitive or offensive content is included in online instruction, there are considerations that may not occur in an in-person lesson. A student may not have immediate access to supports that would otherwise be available in-person. Additionally, such content may be viewed by others in the home. Warnings regarding sensitive or offensive subject matter embedded in outline/syllabus and course materials will allow students to take appropriate action.
- **Classroom Decorum and Limits on Freedom of Expression:** Students participating in online forms of communication including video conferencing or “chat” boards among others are responsible to engage freely and respectfully in the online university environment. The recommended language reminds students of the limits set in the university’s Freedom of Expression Policy, which includes speech or behavior that: is illegal or interferes with the university’s legal obligations; defames an individual or group; constitutes a threat, harassment or discrimination; is a breach of fiduciary, contractual, privacy or confidentiality obligations or commitments; and unduly disrupts and interferes with the functioning of the university.

#### **CONSULTATION:**

- Developed in consultation between E-Learning Task Force, Legal Counsel and Privacy Office.

#### **COMPLIANCE WITH POLICY/LEGISLATION:**

- The attached notifications for course outlines/syllabi are strongly recommended to protect the university and faculty and to ensure that obligations under Ontario privacy law are fulfilled.

- The Provost will consider the advice of the Secretariat and any comments from Academic Council. A revised recommended course outline/ syllabus template will be prepared and published.
