1. CALL TO ORDER

Chair Larry Seeley welcomed all governors, staff and guests to the first meeting of the Board of Governors for 2012-13.

2. INTRODUCTION OF GUESTS

The Chair welcomed guests Don Lovisa, President of Durham College, Tarlochan Sidhu, Dean of the Faculty of Engineering and Applied Science, Pamela Ritchie, Dean of Business and Information

Technology, Victoria Choy, Registrar, Jeremy Bradbury, Assistant Professor, Faculty of Science, and MSc students Brittany Kondo, Jordan Statler, and Erik Paluka.

3. APPROVAL OF THE AGENDA

4. INTRODUCTION AND REMARKS FROM THE PRESIDENT OF DURHAM COLLEGE

President Don Lovisa brought greetings on behalf of Durham College, noting that both institutions did well in the campus cup with the college team winning at women's soccer, and the university team winning the men's soccer, and the jousting match between the two presidents ending in a draw.

He noted that many positive developments are taking place between the college and the university, including the establishment of agreements for the sharing of back office operations, the strengthening of overlapping governance structures, and the development of new pathways between the two institutions.

Mr. Lovisa noted that Durham College is celebrating its 45th anniversary this year, at a time when enrolment has grown by 12%. This brings the total enrolment at the college to over 30,000 students, including full-time and part-time students, apprenticeship and diploma to degree students and adult continuing education and career development participants. He noted that the college has launched 24 new programs to better serve the socio-economic needs in the Durham Region and beyond.

5. SPECIAL PRESENTATION OF STUDENT PROJECTS

Dr. Seeley welcomed Dr. Jeremy Bradbury and students, Brittany Kondo, Jordan Statler, and Erik Paluka, graduates of UOIT's BSc program in Computer Science and who have just started their studies in the MSc Computer Science program. Each student presented a project they developed while students in the undergraduate program, which included a program for visualizing document content, a program that detects and corrects movement for positive muscle memory, and a touch table for tandem language learning. Governors thanked Dr. Bradbury and the students for the innovative and creative ways that they have applied their undergraduate studies to real world problems.

7. MINUTES OF THE MEETING OF JUNE 20, 2012 (PUBLIC SESSION)

8. CHAIR'S REPORT

Board Chair Larry Seeley noted that enrolment at UOIT is up 9% over last year, with growth experienced in all areas, including undergraduate and graduate programs, bridge entrants and international enrolments.

Dr. Seeley also congratulated UOIT on reaching its tenth year milestone and encouraged governors to take part in the celebrations and commemorative events that will be taking place throughout the year.

He also expressed his thanks and appreciation to all governors for volunteering their time and expertise to the governance process at UOIT, noting that it is important to bring all points of view to the issues at hand as they will inevitably lead to better decision making.

9. PRESIDENT'S REPORT

9.1 UOIT Vision, Mission and Vision

President McTiernan reported that the vision, mission and value statements that were initiated by the Board have been reviewed in various forums over the summer months. He noted that the statements will be presented to Academic Council for its endorsement before they are brought back to the Board for final approval.

9.2 UOIT Strategic Plan

Dr. McTiernan reported that the UOIT Strategic Plan has also been subject to significant review over the summer months and two town halls were held at the beginning of September to elicit feedback from the community. He added that Faculties and departments have developed their own strategic plans that build upon the planning priorities and the ways in which they will be achieved within the different units.

10. RECRUITMENT AND ENROLMENT UPDATE

Registrar Victoria Choy provided an update on recruitment and enrolment noting that undergraduate registration was up by 9.4%, graduate registration was up by 53%, and diploma to degree enrolments were up by 26.4% compared to last year. She noted that 40% of students come from the Durham Region, 22% from Toronto, and the remainder from Peel Region, York Region and the greater Ontario area. Internationally, most undergraduate students tend to come from Saudi Arabia, China, and Nigeria; while most graduate students come from Iran, China and Egypt.

11.1.1 Community Infrastructure Improvement Fund

Dr. Seeley noted that although the Board Executive Committee approved this proposal under summer authority, it was being brought forward for full Board approval at this time. Governors expressed their strong support for this proposal, noting that it will be an important initiative for UOIT.

11.2 Governance, Nominations and Human Resources Committee

Ann Stapleford-McGuire noted that governors Heather White and Michael Newell have been appointed by the Lieutenant Governor in Council from September 1, 2012 to August 31, 2015.
