# 1. Approval of the agenda

Motion to approve by S. Forrester. Seconded by H. Kishawy. Approved by consensus.

### 2. Approval of previous meeting's minutes

Approved by consensus.

#### 3. Report of the Vice President Research & Innovation

L. Jacobs welcomed everyone back from the holiday break and wished everyone a Happy New Year. He noted that he has been touring many labs (aprox 40) recently. He noted that there are opportunities for cross-faculty collaborations (e.g. Forensic Science and Forensic Psychology). A recurring theme is the aging of facilities and equipment, how we can share equipment, how we can fund labs and equipment and do it strategically.

L. Jacobs shared that an important goal would be to aim for a major research grant that each faculty could put together, to think about how they could connect with other researchers on campus, and how the university can work toward achieving large scale research grants.

C. Davidson requested examples of collaborative projects that could be inspirational. L. Jacobs gave an example of something UofT is doing on their Mississauga campus and noted that NRC is going to collaborate better with universities. Another example UNB and Quantum Computing.

### 4. Report of the Executive Director, Office of Research Services

J. Freeman provided a presentation (attached) that included information on:

- Staffing Hired: Raluca Dubrowski as Grants Officer, Graham Sue (contract) as Research Partnerships
  Officer, and Queena Zhang (1 semester) as LLP Candidate. Still in process: Research Contracts Officer
  and Intellectual Property Officer (Joe Miller resigned). The Director of Equity, Diversity and Inclusive
  Engagement has been hired and will be starting in the summer.
- Funding Statistics J. Freeman noted that G. Edwards is working on Tri-Agency Financial Guide.
- Undergraduate Research Awards L. Jacobs inquired as to whether faculty contribution increase has been a barrier. J. Freeman Only one or two researchers noted that they missed seeing the increase of funds and they were feeling many costs were being downloaded to them (such as thesis costs). The other option is that the Dean or Faculty could put in additional funds. She noted that there aren't funds in ORS to off-set any funding. It would have to be born centrally. If there was a real hardship we might be able to find funds to support a student.
- REB annual report coming soon.
- Radiation compliance reports are due Feb 28, 2020.
- Biosafety we are now licenced so doing more to educate faculty about the regulations etc.

- TeachingCity Oshawa two projects under development: Patrol Robot and Traffic Monitoring.

J. Freeman also reported on an opportunity with Canarie regarding what software is existing at the institution and how it can it be better utilized and about opportunities for more open-sourced software. B. Chang asked if there will there be a selection committee and does Canarie supply the staffing. J. Freeman replied that Canarie would provide the funding and we would hire the developers. L. Roy noted that it would be good to see the pilot projects. J. Freeman confirmed that that will be done in parallel. **ACTION**: ORS will circulate the Canarie slidedeck to the Research Board once received. **ACTION**: J. Freeman will communicate through the Deans/Associate Deans Research to communicate the program and seeking feedback and project proposals. **Action**: V. Sharpe to distribute J. Freeman's PowerPoint presentation.

### 6. Strategic Research Plan (SRP)

L. Jacobs noted that he's started drafting the SRP using feedback from the survey, consultations and feedback but does not have a draft today. He noted that one recurring theme of the feedback was determining sectors and asked for suggestions for sectors where each faculty has research strengths. He noted that energy is a research area but energy is a large sector of the economy. Another example is Automotive Manufacturing.

The Office of Institutional Research and Analysis (OIRA) has offered to analyze the survey results. **ACTION**: J. Freeman is meeting with them next week.

B. Chang noted that the Stock index in Toronto has 11 sectors:

Financials Information Technology Consumer Stapes
Energy Communication Services Real Estate
Materials Utilities Health Care
Industrials Consumer Discretionary

A. Slane noted that another listing would be employment sectors.

J. Freeman reported that in the last academic year she brought a draft Terms of Reference for Research Data Management committee to the Research Board. The committee is comprised of representatives from ORS, IT and Library and is working to create a strategy for the university including plans for a research data repository.
