BACHELOR OF SCIENCE (HONOURS) PROGRAM IN INTEGRATIVE NEUROBIOLOGY

Provost Richard Marceau introduced Dean William Smith, founding Dean and inspired leader of the Faculty of Science that is the pride of UOIT. The Board acknowledged and thanked Dr. Smith for his outstanding contribution.

Dr. Smith gave an overview of the new program, noting that it is unique in Canada, in that it is fully integrated and includes elements from fundamental biology at the microscopic molecular level, all the way up to the macroscopic level and cognitive psychology. It also has elements of graduate programs, and is expected to be a very popular program. Larry Seeley observed that this is exactly the kind of program that is representative of UOIT on that it is niche-oriented and has an applied aspect.
