CALL TO ORDER

The Chair called the meeting to order at 7:15 p.m.

INTRODUCTION OF GUESTS

ADDITIONS/DELETIONS TO THE AGENDA

The Chair noted an addition to the agenda, as item 8.6 Report of the Nominating Committee.

APPROVAL OF PREVIOUS MINUTES

Dave Broadbent noted a correction to the minutes of April 11, 2007, as he was not in attendance.

Peter Dixon noted a correction to the minutes of April 11, 2007, as the attendance should reflect that he was present.

DECISION ITEMS

Election of Chair and Vice-Chair

Ballots for the election of Chair and Vice-Chair for the 2007-08 year were circulated and collected.

Prior to commencing with the election proceedings, UOIT President Bordessa reported on his concerns regarding continuing under the current model of one Chair for two institutions. He advised that there is a need to ensure that Boards of Governors for UOIT and Durham College are enabled to be positioned to perform their fiduciary duties without conflict. He also referred to correspondence circulated to the Boards of Governors from the legal firm of Heenan Blakely regarding conflict of interest and emphasizing that fiduciary duty is the highest level of duty in law. He further stressed the need for UOIT to be able to focus on its own objectives untethered and independent of Durham College. He indicated that currently, the UOIT Board of Governors has no capacity to decide who becomes Chair, as current practice deems that candidates for Chair must come to the two institutions through an initial appointment to the Durham College Board of Governors, which could cause undue influence to the UOIT Board of Governors.

He further recommended that consideration should be given to having two Chairs, while adhering to the vision and maintaining the original intent for the two institutions to work together collaboratively, which would be identified in the Durham College and UOIT sharing agreement currently being negotiated. The original concept was to ensure that the Boards would maintain a common commitment; however, the

evolution of UOIT as its own entity requires the Boards of Governors to revisit the question of what the appropriate processes and structures are to achieve the vision.is "vision."

UOIT President Bordessa asked that this issue be reviewed and reassessed.

Vice-Chair Simmons requested time to reconsider his candidacy for Chair in light of these <u>observations</u> and an opportunity to speak with the President of UOIT regarding the concerns raised.

Following discussion, the Durham College Board of Governors agreed to defer the election of Chair and Vice-Chair until such time as the issues on the table could be deliberated.

The Chair reported that all collected ballots for the election of Chair and Vice-Chair for 2007-08 will be shredded.

Professional Expense Allowance for Faculty

President Bordessa reported that there is currently a policy in place regarding the professional expense allowance for faculty; however he would like to recommend that it be included in the academic employment policy.

Governors Peter Berg and Manon Lemonde noted a conflict of interest with respect to this issue.

"That the Board of Governors for the University of Ontario Institute of Technology approve the following amendment to the Academic Staff Employment Policy:

In addition to other sources of support provided by University policy for the carrying out of an employee's professional responsibilities to the University, all core faculty members and full-time academic associates are entitled to an annual professional expense allowance. The University shall reimburse employees, up to the maximum as determined from time to time, for eligible expenses through the mechanism of a research account submitted with appropriate documentation in accordance with the University's Business Expense Guidelines. All material and equipment purchases shall be the property of the University. Any unspent balance at the end of the year may be carried forward to the next fiscal year."

Health Education Technology Research Unit

President Bordessa recommended the establishment of a Health Education Technology Research Unit which will be the first research unit in Canada that focuses on the use of advanced technologies in the class room based on thorough research evidence. This research unit focuses on the area of educational technology and using technology in offering distance education courses. The Health Education Technology Research Unit will assist in attracting both faculty and new graduate students and is expected to improve donor interest. President Bordessa reported that any revenue generated through this research unit will flow back to the institution.

President Bordessa noted that many of the teams are comprised of faculty from both UOIT and Durham College. He reported that an informal agreement has been developed between UOIT and Durham College with regard to intellectual property.

Vice-President McErlean noted that the issue of intellectual property as it pertains to Durham College will require further investigation as the college is a Crown corporation. Durham College President Myers indicated that she will report back to the Board in this regard should any further action be required.

DISCUSSION ITEMS

Automotive Centre of Excellence (ACE) Agreement Update

Vice-President of Finance and Strategy Paul McErlean reported that the Automotive Centre of Excellence (ACE) Agreement has now been completed and is awaiting approval.

Vice-President McErlean noted that a detailed report will be brought forward to the Board following the signing of this contract.

REPORT OF THE PRESIDENT

President Bordessa provided a review of the 2007 Application Summary, noting that UOIT is on track and there are no areas of concern. He reported that as of the end of April undergraduate applications are up 4.4% year over year. He also reported on the 2007 Graduating Student Survey, noting that UOIT compares very well while standing out with respect to the uses of technology.

President Bordessa noted that he attended the AUCC semi-annual meeting in Saskatoon in mid-April and plans to attend a session being offered by AUCC in Ottawa this June for new University Presidents.

He further reported that Minister Bentley has denied the Master of Arts (Criminology) program; however UOIT is having on-going dialogue with the Minister's office regarding this issue.

He also reported that a meeting has been scheduled in May by the Ministry of Training, Colleges and Universities with the four GTA Universities. The focus of the meeting will be on the expected growth in demand for GTA universities by students residing in the GTA who elect to remain at home while attending university. The Ministry is intending to develop a strategy, in consultation with the GTA universities, to address this issue.

REPORT OF THE CHAIR

The Chair reported on upcoming events including: the ACCC Conference in Montreal, Quebec on May 27-29, 2007; the UOIT Convocation at the General Motors Centre in Oshawa on June 1, 2007 at 10:00 a.m. and 2:30 p.m.; the Farewell to Governors Dinner at Harpo's Restaurant in Oshawa on June 21, 2007 at 7:00 p.m.; the Durham College Convocation at the General Motors Centre in Oshawa on June 22, 2007 at 9:30 a.m., 1:30 p.m. and 5:30 p.m.

INFORMATION ITEMS

UOIT Governor Broadbent reported that he is aware of some negative press regarding Durham College and UOIT students in neighbourhoods close to the Oshawa campus. Donna McFarlane, Vice-President of Marketing and Communications, noted that a Town and Gown Committee was established in 2005 and is composed of community representatives as well as Gary Pitcher, Director of Student Conduct, and herself. She indicated that this committee is very effective and is supported by the DC-UOIT Student Association. She reported on recent issues, indicating that a neighbours' coalition has now been formed to address issues around absentee landlords and upkeep of the properties.

The Chair asked for a report to be brought back to the Board of Governors on a quarterly basis.
